SECTION 6: EXHIBITOR TERMS & CONDITIONS

Pacific Sports LLC (PS) and the exhibitor must agree:

1. To have booth open and staffed during the event.
2. Displays will not visually or physically disturb aisles or adjacent exhibitors.
3. Agrees to not sublet space or exhibit any merchandise other than that specified on expo sign up form without permission of management.
4. Conform to all Cleveland, Ohio Fire Department Rules and Regulations.
5. Electrical wiring/installation shall be handled prior to the event through Hilton Garden Inn Cleveland Gateway, Voinovich Bicentennial Park, and PS.
6. Prior to the Cleveland Triathlon all booth material (literature/products/etc.) must be approved by PS.
7. PS has the right to change booth space assignment prior to event.
8. PS has the right to reject or restrict any exhibit.
9. No exhibitor shall have the authority to incur costs or liability against the Cleveland Triathlon, Pacific Sports LLC, Hilton Garden Inn Cleveland Gateway, Voinovich Bicentennial Park, City of Cleveland, Volunteers, and any sponsors associated with the event in connection with any and all of the above. Exhibitor shall be liable for all damages that he/she may cause to the site in connection with exhibit.
